

# MEMORANDUM OF UNDERSTANDING

This MOU is made and executed at Bhopal between M/s. Sofcon India Pvt. Ltd., having its office at 706-707, Northex Tower, GD-ITL, Netaji Shubhash Marg, Pitampura, Delhi-110 034 (hereinafter referred as Sofcon India) represented by

#### **AND**

Gyan Ganga Institute of Technology & Science, Jabalpur represented by Sura. Arong its campus office Bargi Hills, Jabalpur, Madhya Pradesh-482003 and the institute at same place, hereinafter referred to as "GGITS".

This expression shall mean and include its successors and legal representatives of both the party.

# NOW THE PARTIES HEREBY MUTUALLY AGREE AND THIS AGREEMENT WITNESSED AS UNDER:

## Roles and Responsibilities:

- (A) Sofcon India:
- Will provide hands-on training in the field of rapidly growing technology to passing engineers and perpetual need to keep abreast with latest developments in the field of automation (PLC/SCADA) system Technology/MATLAB/VLSI/Machine Design & Automation/HMI (for Electrical & Electronics Engg. and Electrical Engg. students) etc, and other engineers to be for training duration at the
- (2) Sofcon India has agreed to setup training labs. for training duration at the premises of GGITS- Jabalpur. Expenses incurred in setting up the lab will be borne by Sofcon and all the hardwares, Sofwares and accessories required for establishing this lab will remain sole property of Sofcon India.
- (3) The training program, branch, year/semester duration, course and fee per participant will be mutually agreed.

- (4)Sofcon will conduct a placement drive after successful completion of the program. (On collection of INR 30,000/- we will place one student).
- (5) Industrial Visit and guest industrial lecturers will be organized by sofcon.

**(B) GGITS:** 

- (1)GGITS has agreed to provide Labs, Infrastructure Covering Training space, Lighting, Furniture, Computer hardware, UPS supply etc. required for training.
- GGITS will not hire automation Engineers employed by Sofcon India. (2)

**Terms and Conditions:** 

- Both parties affirm their commitment to implement the activities and achieve (1)the objectives mutually agreed upon.
- Any conflict between the parties shall always be decided by mutual (2) consultation without any recourse to arbitration or other kind of legal remedy including resort to a court of law
- Both parties shall use such material, name, logo, information as pre-approved (3) and provided by each party, for any of its advertisements for promotional material on their web-sites.
- New assignments can be added during the course of implementation of **(4)** MOU, if mutually agreed by both the parties.
- Financial terms and conditions will be decided mutually as per need. (5)

## Validity of the MOU:

This MOU shall remain in force and effect for Twenty Four (24) months. Either party can revoke this MOU by giving one month notice.
